

# The Constitution of PASC District 13

## Article I ~ Name

### Section 1

The name of this organization shall be Pennsylvania Association of Student Councils, District 13, Region G

## Article II ~ Purpose

### Section 1

The purpose of this organization is to prompt active participation in school government, provide member schools an opportunity to exchange ideas, and provide leadership training for member schools.

## Article III ~ Membership

### Section 1

Membership shall be open to any high school and junior high /middle school in Berks and Schuylkill Counties with a student council.

## Article IV ~ Executive Board

### Section 1

The Executive Board shall consist of:

- A. The District Director
- B. Two senior high students.
- C. Two junior high /middle school students.
- D. The advisors of the elected students.
- E. The current conference host advisor and student chairpersons.
- F. The Region G Student Representative, if from District 13.

### Section 2

The District Director shall be the chairperson of the Executive Board.

### Section 3

The Executive Board shall meet at the discretion of the District Director, at least two meetings shall be held each year.

## Article V ~ The District Director

### Section 1

The District Director shall be elected for a three year term, and shall be responsible for adhering to the District Director guidelines set by the PASC Executive Board.

### Section 2

The District Director is responsible for preparing a financial statement to be presented at the spring conference. A copy shall be submitted to the PASC Executive Board at the August board meeting.

### Section 3

The District Director shall be paid an honorarium of \$300 each spring of his/her term.

## Article VI ~ Annual Conference

### Section 1

An annual conference shall be held in the spring each year.

### Section 2

The date of the conference will be set by the host school with the approval of the Executive Board.

### Section 3

Additional conferences and workshops may be added at the discretion of the Executive Board.

### Section 4

Any surplus monies from District Conferences shall be deposited in the District 13 Treasury.

## Article VII ~ Dues

### Section 1

The annual dues for membership in the organization shall be determined by the PASC Executive Board and assessed as part of the PASC annual dues.

## Article VIII ~ Headquarters

### Section 1

The District 13 headquarters shall be determined by the District Director.

## Article IX ~ Constitution

### Section 1

This constitution must be ratified by a two-thirds vote of the schools attending the spring meeting.

### Section 2

For purpose of ratification, each school shall cast one vote.

## Article X ~ Amendments

### Section 1

All proposed amendments to the constitution must be submitted to the District Director. After favorable action by a majority of those members present at a meeting of the Executive Board, the proposed amendment shall be submitted to a vote at the spring conference.

### Section 2

Amendments to this constitution must be approved by two-thirds vote of the schools attending the spring conference.

## By-Laws

### Article 1

The executive Board shall offer two scholarships to the PASC Summer Workshop Program each year, if finances permit.

Article 2

The Executive Board may contribute financially to send the student Region Representative from District 13 to the NASC Conference , if finances permit.
