



# Advisor Commitment Form

Please review, sign and return with the following Advisor Commitment Form for all advisors attending the 2022 PASC State Conference

- Advisors must ensure a completed registration process for their entire delegation by Friday, September 30th. Late registration will not be accepted.
- Advisors must attend the Advisor Meeting before the general session on Friday. During this meeting, you will receive updates on changes, important information, and have the chance to ask any questions you may have about the conference.
- Advisers must attend all the general session meetings, breakout sessions, and events to supervise student delegates- making certain their students are on time and attending all sessions. Advisors are to sit with their respective delegation during general sessions.
- Advisors are responsible for the behavior and attire of their students at all times and at all events. The following behavior is not allowed: talking during presentations; use of electronic devices or headphones during sessions; interfering with delegate/staff members' ability to participate; inappropriate attire; running in hallways; and creating an intimidating, hostile, or offensive environment. Advisers witnessing inappropriate behavior - even by students from other delegations - should speak to the student(s) involved.
- Advisors must review responsibilities and expectations outlined in the Student Commitment Form with their student delegates to clearly define expected behavior prior to signing this form.
- Advisors are responsible for bringing a copy of every delegate's medical form for themselves and their delegates. Copies will not be provided by the conference host.
- Advisors must check students' sleeping rooms at the stated curfew to confirm that students are in their own rooms and quiet. Additional security guards will be on duty during our conference. At any time should complaints or problems arise, the advisor(s) will be notified to correct the situation.
- **COVID Policy:** I recognize the World Health Organization declared a global pandemic due to the Covid-19 virus, which is spread in part due to proximity to others, such as what might be encountered during a conference. I acknowledge all such risks are known and understood by my school district in light of our decision to send our students to attend the Pennsylvania Association of Student Councils (PASC) State Conference. While attending the conference, my students will comply with all local, state, and federal policies regarding Covid-19 mitigation efforts in effect at the time of the PASC State Conference. I further agree my students will abide by the policies of PASC as well as the Boyertown Area School District while in attendance at the event. This includes, but is not limited to, the wearing of masks and social distancing, as well as any other mitigation actions required by any of these entities at the time of the event. As their advisor, I will review these rules with my students, enforce these rules with my students while in attendance at the conference, and model the expected behavior by following these guidelines myself.
